About this Consultation

The purpose of this consultation note is to seek industry feedback on proposed changes to certain financial services fees (the "Fees") present in the following legislation.

- a. Private Funds (Fees) Regulations;
- b. Private Funds (Annual Returns) Regulations;
- c. Mutual Funds (Fees) Regulations;
- d. Mutual Funds (Annual Returns) Regulations;
- e. Banks and Trust Companies (Licence Applications and Fees) Regulations;
- f. Private Trust Companies Regulations;
- g. Building Societies Act;
- h. Cooperative Societies Act;
- i. Companies Management Regulations;
- j. Insurance (Applications and Fees) Regulations;
- k. Insurance (Portfolio Insurance Companies) Regulations;
- I. Money Services Businesses Regulations;
- m. Securities Investment Business (Licence Applications and Fees) Regulations;
- n. Securities Investment Business (Registration and Deregistration) Regulations;
- o. Monetary Authority Act;
- p. Companies Act;
- q. Limited Liability Companies (Fees) Regulations;
- r. Limited Liability Partnership (Fees) Regulations; and

This paper presents the proposed changes to the Fees for certain regulated activities. These Fees are expected to be approved/passed by Cabinet and/or Parliament in 2024, but would come into force for the 2025 calendar year. The Ministry welcomes any feedback on the proposed Fees.

Background

Industry may recall that the Hon. Premier, in her 2024-2025 Budget Policy Statement, referred to enhanced revenue streams to achieve broader economic and budgetary objectives. The revenue streams also would support regulatory activities that have increased on account of global developments as well as support positive growth in certain key products and services.



As a result, the Ministry for Financial Services and Commerce (the "Ministry") in consultation with its corresponding authorities and agencies has comprehensively reviewed financial services fees.

Importantly, the review identified certain Fees that have not been increased in over 5, 10, 15 years or, in a number of instances, longer. Whereas, despite the evolution and growth of regulated activities, a corresponding increase in staffing and other resources has not proportionately occurred.

The Ministry has therefore identified certain areas where new Fees are warranted given the resources required for regulatory oversight of those activities. For instance, per below, the Ministry is proposing changes to the Annual Fees charged to entities to take account of services managed by the Department of International Tax Cooperation, which to date has not introduced any fees.

However, please note that increases have predominantly been kept at or below the total inflationary increase since fees were last revised; and, with a few exceptions, the increases are incremental to mitigate a material adverse impact on the industry.
